5. CONDUCT

All persons on the Club's property, inside or outside the club house, are required to conduct themselves in an orderly manner so as not to cause nuisance or offence to other persons.

SMOKING

Smoking is not permitted anywhere in the Club except for the designated smoking room located at the front of the Club.

DRINKING

Consumption of drinks at the bar counter is not permitted. Members, guests and visitors are required to consume their drinks away from the bars.

THE LIQUOR CONTROL ACT PROVIDES THAT IT IS AN OFFENCE FOR A LICENSEE TO;

- 1. Supply liquor to an intoxicated person.
- 2. Allow an intoxicated person on the premises.

If you are intoxicated, violent or quarrelsome you must leave the premises when asked.

6. COMPLAINTS

All complaints are to be addressed in writing or emailed to the Club Manager.

Under no circumstances may a member reprimand a member of the staff.

7. CLUB ACCESS

Unauthorized persons are not permitted to enter the kitchen, staff room, offices, store rooms, bars or coolrooms. The doors at the northern side of the building and the Yarrowee St entrance are for the use of bowling members and bowls participants only. Other members and quests are required to use the main entry.

7. CLUB ACCESS (CONT.)

Subject to any provisions of the law (ie, in relation to persons under the age of 18 years), all public areas of the club are accessible to financial members of all categories and eligible visitors, except as decided and notified by the Board. It will be necessary from time to time to restrict access to certain areas, for example in case of special functions or bowls tournaments. Signs will be displayed to notify such restrictions when they apply.

BISTRO; orders are placed at the register and customers are given a number which will appear on a screen when you meal is ready. Meals are to be collected at the servery. Meals are to be consumed only within the bistro and gaming areas. Snacks such as chips etc, purchased within the club are permissible in other areas subject to the consumer accepting responsibility for discarding containers and wrappers properly and keeping tables and surrounding areas tidy. Other than the usual arrangement relating to bowls activities, no food is to be brought into the club.

CHILDREN; refer to point 1 - visitors, parents must have direct control of their children at all times. They are not permitted to roam unsupervised inside or outside the club house. It's an offence to leave children in the car and anyone caught doing so will be reported to the authorities.

CAR PARKING; All bowling members must park their cars in the southern end of the car park. They are not permitted to park in front of the club. All other patrons are permitted to park anywhere in the car park.

The Board of Management is committed to maintaining the Club's standard by the enforcement of rules designed to ensure the peaceful enjoyment of the Club Members, guests and eligible visitors.

The Club's rules are set out in the Constitution and Rules Handbook. Copies are avaliable from the office. Members, guests and visitors are required to comply with all provisions of the law and the Club's rules. Breaches may render the offenders liable to expulsion.

The following is a summary of the Rules which most directly, but is not limited too, affect day to day Club attendance.



1. TRADING HOURS

Mon to Wed	9.30am	to	12am
Thurs to Sat	9.30am	to	1am
Sunday	8.30am	to	11.30pm

Or such other hours as may be adopted by the Board.

Persons on the Club premises at closing times are expected to vacate the building quietly and without undue delay.

2. VISITORS

Persons who reside outside a radius of 10km from the Club are eligible to attend the Club and use all the amenities available to visitors. They must carry and produce on request an acceptable form of identification and must register in the visitors book before entering the Club.

Persons who reside within a radius of 10km of the Club may, if they are not members themselves, attend the Club only as a guest of a financial Bowling or Social member. They must first register in the visitors book and be signed in by the host member in whose company they must remain for the entire duration of their visit. Such persons are encouraged to seek membership (for which they must complete an application for membership and obtain eligible proposer and seconder).

Life, Special, Financial Bowling and Social Members may introduce guests (not exceeding 4 at anyone time).

A non-member may not be a guest more than 8 times in any one year.

Persons, other than junior members, under the age of 18 years may enter the club only;

- 1. In the company of a parent or legal Guardian; or
- 2. As guests of members as above but purely for the purpose of partaking in a meal.

NO PERSONS UNDER THE AGE OF 18 YEARS IS PERMITTED TO ENTER THE GAMING ROOM.

3. MEMBERS

Members are required at all times to carry their membership cards and an acceptable form of identification and be prepared to present them on request.

FINANCIAL BOWLING MEMBERS, LIFE MEMBERS AND SPECIAL MEMBERS may enjoy all the facilities of the Club without restriction (other than provided in the rules).

FINANCIAL SOCIAL MEMBERS accept that they have no voting rights and cannot stand, nominate, or second for office and may enjoy much the same privileges as bowling members.

GAMING MEMBERS have the full use of the Club's gaming facilities and may use the bar and bistro. THEY MAY NOT attend social functions of the club unless a guest of a bowling or social member. THEY MAY NOT introduce guests to the club.

4. DRESS CODE

Minimum requirements at all time are;

NEAT, CLEAN CASUAL.

Items not permitted at any time include, but not limited to;

Thongs, moccasins, bare feet or any shabby footwear. Soiled, tattered or torn clothing and work clothes. Clothing deemed immodest or offensive in style or design. Swimwear including board shorts and football shorts. Tracksuits.

MANAGEMENT RESERVES THE FINAL RIGHT TO REFUSE ENTRY.
