TERMS AND CONDITIONS OF ENTRY

1. Terms and Conditions: These Terms and Conditions of Entry include information on how to enter and Prizes. Participation in the "Members Draw" Promotion is deemed acceptance of these Terms and Conditions of Entry.
2. Period: The Draws will take place each Thursday evening at 7pm and 8pm commencing Thursday 5th July and ending Thursday 6 December 2018.
3. Participating venue: The Promotion is only available at Sebastopol Bowling Club, 213-219 Albert Street, Sebastopol, Victoria 3356. (the Venue). The Promotor is the Sebastopol Bowling Club Inc. (the Club)
4. Eligibility: Entry is open to all members of the Club, over 18 years of age. Entry is not open to employees of the Club.
5. How to enter: Members must be present at the Venue at the time of the Draw and have their membership card with them. It is not a precondition to entry to the Draw that you play a gaming machine, or participate in a loyalty scheme that requires expenditure on gaming machine play or agree to receive gaming machine advertising.
6. The Draw: A membership number will be selected from the random number generator at 7pm and at 8pm on each day of the Draw. The winning member's name will be announced and the winner has 2 minutes after the announcement to claim the Prize. The winner must show their membership card and driver's license to claim the Prize. If the member has not come forward after 2 minutes the Prize will jackpot to the following draw.
7. The Prize will start at \$500 and if not won will increase by \$25 each draw to a maximum of \$2375, until the Prize is won. Once the Prize is won the Prize amount will be reset to \$500 for the following Draw.
8. The winner's name will be published on the Club's website or facebook page, as soon as practicable after winning, for a period of not less than 28 days.
9. Delivery: The Prize will be available for collection from the Venue, at the conclusion the Draw.
10. No waiver: Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.
11. Club's decision final: If there is a dispute concerning the conduct of the Promotion or awarding of the Prize, the Club's decision will be final and no correspondence will be entered into.

12. Cancellation / delay / modification: If, for any reason whatsoever, any part of this Promotion is not capable of running as planned, the Club reserves the right to cancel, terminate, delay, relocate, modify or suspend any or all of elements of the Promotion, subject to the written directions from any regulatory authority.
13. Privacy: Personal information collected for the Promotion will not be used for any purpose other than for the conduct of the Promotion. The Club complies with the Australian Privacy Principles. To gain access to the personal information held by the Club phone or write to the Club at the address set out below.
14. Publicity: Players consent to the Club using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of advertising this Promotion, and promoting any of the Club's products or services.
15. Limitation of liability: Except for any liability that cannot be excluded by law, the Club, its employees and agents, will not be liable for any loss, damage or personal injury whatsoever (including negligence), which is suffered, incurred or sustained in any way in connection with the Promotion.
16. Governing law: The laws of the State of Victoria govern the Promotion.
